Busy shift. Officers responded to a damaged property call. The suspect was still on scene and arrested for felony vandalsim due to shattering a window. While on scene, an involved

party reported domestic violence that occurred the day prior involving the same suspect. The suspect was additionally arrested on a separate charge for felony domestic violence. She was booked into jail for both incidents. Officers responded to a vehilce collision with the driver leaving the area. Officers located the driver who was intoxicated. A DUI investigation was initiated and based on that, the driver was arrested for DUI related charges and booked into jail. Officers investigated a domestic dispute between a male and female. Upon arrival the suspect fled from officers. Officers on scene established that suspect had violated a court order, held the victim against her will, kept a witness from speaking with police and violated his probation. The male was located on foot in which he fled from officers multiple times. He was ultimately located and taken into custody. He was booked into jail for the previsouly mentioned crimes.
