#### SUPERVISOR COMMENTS

Monday proved to be a busy day for officers. Officers finished briefing and immediately started to handle calls for service. During the day, TPD received a call from a school resource officer, requesting that other officers respond to a high school to assist with a female who was being suicidal. A female was making threats of committing suicide and threatened to assault staff. It was discovered that she has not taken her mental health medicine for 3 days. She did not want to get handcuffed or detained on a mental health hold. Multiple officers had to hold her down to keep her from hurting herself until AMR arrived to transport her to DMC. Officers later responded to a male who was seen punching his small dog. The male was a recent transplant from Oregon. He had an outstanding warrant and he was arrested for it. Animal Control is investigating possible animal cruelty, and the dog was taken by Animal Control for its safety until the male can have an animal hearing for its release.

#### SUPERVISOR COMMENTS

The shift was steady from the get go. It got busy all at once with a hit and run injury accident, and fire asking for assistance with traffic control on a structure fire. Officers were able to track down the suspect in the hit and run as he was fleeing on foot down the street. He hit another vehicle causing injuries and hit a property owner's fence with his vehicle. He was arrested for felony hit and run and had a warrant for his arrest. A male was arrested and booked for trespassing and narcotics charges after he refused to leave a business property. A security guard asked him to leave several times and he refused and instead decided to throw trash at the security guard. During a search, he was found to have methamphetamine in his possession.

#### SUPERVISOR COMMENTS

Officers were dispatched to a violation of court order in-progress. The suspect had several outstanding warrants as well as an active restraining order from the victim. The victim was also reporting a domestic battery that had just occurred prior to the suspect fleeing when she called police. Officers arrived in the area and located the suspect running down an alley, away from officers. After a short foot chase the suspect jumped a fence and was met on the other side by additional officers. He was taken into custody and during a search incident to arrest he was found to be in possession of a loaded flare gun, several individual bags of meth, and a significant amount of cash. He was booked for all the warrants and several other fresh charges related to drug sales, possession of a firearm by a felon, resisting arrest, domestic battery, and violation of a restraining order. He was booked into jail.
